## Assumption of the Risk and Waiver of Liability Relating To Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

**Lamb City Campground (“the Campground”)** has put in place preventative measures to reduce the spread of COVID-19; however, the Campground cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, **staying at the Campground could increase** your risk and your child(ren)’s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren) and I may be exposed to or infected by COVID-19 by attending the Campground and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed or infected by COVID-19 at the Campground may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Campground employees, volunteers, and Campground guests and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, or that I or my child(ren) may experience or incur in connection with my child(ren)’s attendance at the Campground or participation in Campground programming (“Claims”). On my behalf, and on behalf of my child(ren), I hereby release, covenant not to sue, discharge, and hold harmless the Campground, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Campground, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after staying at the Campground.

Compliance with National, State and Local COVID-19 Regulations is required by management.

Any National, State or Local regulation issued that supersedes these park rules for COVID-19 will automatically be in effect. Anyone who does not comply with the park guidelines or COVID-19 regulatory requirements by National, State or Local Authorities is subject to immediate removal.
